Whatever Happened to Bob "B-1" Dornan?





THE WAR OF THE TITANS

The "Titanomachia," or the Titans would be permitted to reign as a god until War of the Titans, was brought about mainly bethe end of time. cause of the attitude that

Styx, a goddess who dwelt in a lofty grotto at the entrance to Hades, was the first to pledge her support of Zeus. She also pledged the support of her four children, whose names were Bia (Force); Cratos (Strength), Nike (Victory) and Zelus (Emulation). Prometheus (the savior of mankind) aligned himself with Zeus, as did all of the Olympian gods.

All of the Titans except Oceanus supported Cronus. They took their position in the Othrys Mountains of Southern Thessaly and the forces of Zeus occupied Mt. Olympus, about fifty miles to the north. The broad plain between these two mountains became the scene of a gigantic battle which continued for ten years without

either side gaining a victory. Finally, in desperation, Zeus sought the advice of Grandmother Gaea. She advised aid from the Hecatoncheires (hundred-handed monsters) and the Cyclopes whom Cronus had previously imprisoned in the dungeons of Hades. Zeus immediately went to the lower world, slewed the dragon that was guarding these dungeons and released the prisoners.

The liberated Gargantuan creatures stormed onto the plains; their thunder, lightning, and great strength provided just the added power that was necessary to gain a victory for Zeus. Those defeated Titans were then hurled down into Hades and enclosed within walls of brass. The hundred-handed monsters were designated to be their relentless jailers for the rest of time. Atlas, a secondary Titan, was punished by being forced to hold the heavens upon his shoulders for all of eternity.

Massachusetts 2014 Ballot Questions

On November 4th Massachusetts voters will decide whether to enact any of four proposed laws presented in the form of binding statewide ballot questions.

Question 1 is a proposed law to eliminate the requirement that the state's gasoline tax, which was 24 cents per gallon as of September 2013, be adjusted every year by the percentage change in the Consumer Price Index over the preceding year, but not be adjusted below 21.5 cents per gallon.

A YES vote would repeal the current law, enacted by the legislature, that automatically increases the gas tax every year without a vote. For information regarding why you may wish to vote YES, call Steven Aylward at 617-744-0760.

A NO vote would keep the current automatic tax increases in place. For information regarding why you may wish to vote NO call the Committee for Safer Roads and Bridges at 617-391-9663.

Question 2 is a proposed law to expand the current Bottle Bill by requiring deposits on containers for all non-alcoholic non-carbonated drinks.

A YES vote would expand the Bottle Bill. For information regarding why you may wish to vote YES call Coalition for an Updated Bottle Bill at 617-747-4322.

A NO vote would leave the current law as is. For information regarding why you may wish to vote NO call Comprehensive Recycling Works at 617-886-5186.

Question 3 is a proposed law to prohibit casino gambling. A YES vote would repeal the law, passed by the legislature, which legalized casinos and lead to the recent approval of a yet-to-be-built casino in Everett. A NO vote would make no changes to current law. For information regarding why you may wish to vote NO call Domenic Sarno, Mayor of Springfield, at 617-520-4559.

Question 4 is a proposed law which would entitle employees to earn and use sick time according to certain conditions.



Saint Padre Pio

Francesco Forgione, was born on May 25, 1887. He was the son of Giuseppa and Grazio Forgione, peasant farmers, who lived in the small Italian village of Pietrelcina. Francesco was very devout even as a child, and at an early age felt drawn to the priesthood. As a young boy, he was able to see and communicate not only with his guardian angel but also with Jesus and the Virgin Mary. In his simplicity, he assumed everyone had the same experiences. ordained to the priesthood on August 10, 1910 after seven years of study and became known as Padre Pio.

On September 20, 1918, Padre Pio was kneeling in front of a large crucifix when he received the visible marks of the crucifixion, making him the first stigmatized priest in the history of Church. The painful wounds would remain with him for 50 years. The doctor who examined Padre Pio could not find any natural cause for the wounds. Upon his death in 1968, the wounds were no longer visible. In fact, there was no scarring and the skin was completely healed. He had predicted 50 years prior that upon his death the wounds would heal.

The wounds of the stigmata were not the only mystical phenomenon experienced by Padre Pio. The blood from the stigmata had an odor described by many as similar to that of perfume or flowers, and the gift of bilocation was attributed to him as well as healing, prophesy and discernment of spirits. When a friend once questioned him about these charismas, Padre Pio responded, "You know, they are a mystery to me too." His day began at 2:30 in the morning when he would rise to begin his prayers and prepare for Mass. His regular workday lasted 19 hours divided between Mass and confessions. He was able to carry on with just a small amount of sleep and food. He rarely left the monastery and never took a day's vacation from his grueling sched-

Whose Nation was Red Sox Nation?

As I read the Boston Globe this past Sunday, I took my time reading "Memories Still Haunt Harper," September 21st. It was time for Tommy Harper to put it all out there for all to read. What he relayed, most of us already knew, about the ugliness of Tom Yawkey's reign with the Red Sox and Fenway Park.

As a baby boomer, I spent most of my childhood only hearing about how good the Red Sox once were. For me, it was a long drought of horrible losing seasons with teams so tattered they should have been down in Triple A somewhere, anywhere but Fenway. It was painful being a Red Sox fan back then. This was long before Red Sox Nation was born. There were a few bright moments like Dick Radatz on the mound or Tony Congiliaro at bat, but even that one went so wrong too.

I was at Fenway on September 28, 1960, sitting in the right field grandstand when Ted Williams hit his final home run in his final at-bat in his career. The Williams Era had ended, yet the sad era of how African American ballplayers were treated apparently was still very much alive. I had heard the stories how Jackie Robinson got a Red Sox tryout, but was sent on his way to a great career with the Brooklyn Dodgers and the Hall of Fame. I also heard about the alleged decision not to even give Willie Mays a tryout.

In 1959 at age 11, I remember when Pumpsie Green was brought up as the first Black player in Sox history, but the last in the American League to do so. I remember Earl Wilson who came up a few months later. I didn't even realize at the time I was watching history being made.

However, what really hit me in the Harper piece on Sunday was how he had to endure so much because of his skin color. I don't know how he hung in there so long over the years. Other players would have been filled with anger over the racist climate of the times and seemingly Boston's ball club too.

I remember Reggie Smith and the reaction he received in the sports press for speaking out. Smith was called an angry Black man, but he had a lot to be angry about. Harper's memories are too important not to be shared. If we don't remember our past, it could repeat. We need to learn all the lessons we can to ensure that the future is



L'Anno Bello: A Year in Italian Folklore Finding Light in the Darkness

The other day, I held a gettogether at my home, surrounded by family, to celebrate autumn. As we gathered in the honey-colored glow of the dining room, we ate potato dumplings — in honor of Oktoberfest! - and my mother's seafood rice, then finished with pumpkin bread and an apple-almond tart for dessert. The conversation naturally turned to the season, to the seemingly sudden onset of fall and the approaching winter. Several of my family members started to bemoan the darkness that, perhaps more than anything, truly heralds the arrival of the autumnal days. I can certainly understand the often overwhelming sensation that accompanies this early darkness, as the night envelopes the Earth with its heavy velvet cloak. However, I also believe that this darkness can be beneficial. It beckons us back home, into the warmth of the hearth and the arms of family and friends. It provides us with great repose, allowing us time for reflection or personal projects in the long night. Most importantly, the darkness helps us appreciate the light — the glorious light of fall — so much more. September ends with a holiday honoring the rhythmic darkness of autumn: the ancient feast of Michaelmas.

St. Michael's Day, also known as Michaelmas, falls on September 29th. It commemorates St. Michael the Archangel, who is often depicted holding scales in his hands. The scales are reminiscent of the balance between light and darkness that occurs around the authis day with seasonal as allow the darkness to metawell as religious significance. ditions Michaelmas serves as a sort of harvest festival, dedicated to specific foods. In England, for example, roast goose is the dish associated with Michaelmas, and a superstition declares that those who eat goose on St. Michael's Day will have money all year long. Carrots and oat cakes, on the other hand, were the preferred Michaelmas staples among the medieval Scots. In Italy, this feast is known as il Giorno di San Michele l'Arcangelo. A harbinger of fall, Michaelmas signals the start of colder weather and the beginning of the school year for Italians. It's also a feast day peppered with a number of seasonal proverbs, many related to food or weather. One famous Michaelmas dictum states that a San Michele, l'uva é come il miele — meaning that on St. Michael's Day, the grapes are as sweet as honey, speaking to the grape harvest underway around now. Another proverb explains that a San Michele, il calore va in cielo. Literally saying that the heat goes up into the sky on Michaelmas, this particular proverb reminds Italians of the cool autumn weather that will only intensify after St. Michael's Day. When I think of St. Michael, I think of the small white church dedicated to the saint nestled among the mountains in my father's hometown of Sulmona. In Italy, saints are deeply entrenched in the fabric of everyday life, lending renowned meaning to food, traditions and the pas-

sage of time. The holiday of Michaelmas heralds darker, cooler auphorically overtake me, how-

respect it as a necessary part of the season. When the tenebrous night sky ushers me into the comforts of my home, I love to spend that time baking in the warmth and coziness of my kitchen. Usually the summer heat is not conducive to baking, but the crisp and dusky fall nights make me want to linger in the kitchen as delectable autumnal scents apples and pears and tangy spices - fill the air. In fact, every year I make gingersnap cookies for Michaelmas, as ginger is another ingredient connected to the holiday and a staple in the sumptuous medieval feasts that once marked autumn festivals. The darkness of fall excites me for the mysteries still present in the world today, for spine-tingling spooky stories and the retelling of olden legends. How powerful would Halloween be, after all, without the shivering sense of anticipation brought on by the shadowy night? Finally, the shortening days cause us to appreciate the light even more. Knowing that the day will end so early, I love to gaze upon the butteryellow glow of late afternoon sunlight shining through the colorful leaves. This appreciation for the sun fuels the symbolism behind the upcoming winter holidays - Advent, St. Lucy's Day, Hanukkah, Christmas, Kwanzaa, New Year's Eve — that emphasize that light breaking the darkness. Without the long nights that occur after the autumn equinox, such a deep-rooted symbolism with all of its implications to the human consciousness would be lost.

The season of autumn provides us with many reasons to celebrate. The beauty of leaves bursting with red and orange and golden hues is truly breathtaking. The harvest grants us a bounty of food to make and share, generously bringing forth tart apples and creamy pumpkins. However, we should add the lengthening evenings to the list of things we appreciate about fall. Darkness encourages us to spend time with loved ones or in tumnal equinox, marking tumn days. Rather than the peace of our own home, reflecting on what is dear to us. It opens our eyes to the spooky mysterious of the world, enough to bring out the inner child that dwells within us all. And the darkness causes us to appreciate the light which nourishes us every day and comprises a basic need in our human existence. An old proverb wisely proclaims that it is better to light a candle than curse the darkness — so let us keep lighting our candles, made of love and family and Earth's abundance, all season long. 

WEST END MUSEUM ITALIAN HERITAGE MONTH HONOREE NIGHT. 7:00 PM. Honoring current and former West Enders of Italian heritage who have contributed Tuesday, to preserving the culture of the West End and its rich immigrant history. This years' honorees: Joseph Caruso (posthumously d.March 5, 2008) and Theresa Raso. October 7 Joseph Caruso, was an activist who worked to save the West End during urban renewal in the late 1950s. He was born in Italy and moved to the West End with his family when he was 7. When the city decided to raze the neighborhood, Mr. Caruso made the area's preservation his goal. With five of his friends, Mr. Caruso, who lived with his family on Green Street above a fish market, started a committee to save the West End and turned a store on Staniford Street into the committee headquarters. The committee sent out fliers to rally residents. Herbert Gans, a professor at Columbia University and author of the Urban Villagers said: "This was a time when local neighborhood activism was unknown. They [the committee] labored bravely." In the 1980s Mr. Caruso continued working to preserve West End history by helping Jim Campano establish a West End newsletter. **Theresa Raso** grew up in South Boston and married former West Ender Vincent Raso in 1961. They lived in Acton for most of their marriage raising 4 boys. Theresa taught school in Cambridge and later worked as an accountant while raising a family. In 1996, after her children had grown up, she and her husband Vinnie moved to Whittier Place in the West End. Immediately she got involved with St. Joseph's Church and also volunteered with Neighborhood Action (now Oasis) to help feed the homeless. A few years later she put her accounting skills to work as longtime treasurer of both the West End Civic Association and the West End Community Center; Theresa is also one of the founders and organizers of the West End Children's Festival. 





VEGETABLE MEDLEY

2 medium potatoes

1/2 pounds fresh, frozen or canned string or cut beans1 large garlic clove

- 1 medium zucchini sliced (1/2-inch pieces) not peeled
- 1 medium yellow squash sliced (1/2-inch pieces) not peeled

2 large ripe tomatoes or a four-ounce portion crushed

four-ounce portion crushed tomatoes

1/3 cup olive oil

1 chopped medium onion

1 tablespoon capers

3/4 tablespoon basil Salt

In a saucepan, sauté onion and capers in oil until opaque. Add chopped ripened tomatoes or four ounces of crushed tomato. If you prefer a heavier sauce, use a four-ounce can tomato sauce instead. Add fresh or dried basil. Stir, cover and simmer slowly. Meanwhile, peel and cube potatoes. Wash and set aside. If using fresh string beans, cut ends off, wash and set aside. Add potatoes and beans to saucepan. Stir, cover, and simmer slowly for ten minutes. Add sliced zucchini and yellow squash (optional). Salt to taste. Add water if more liquid is desired and bring to a boil. Cover and simmer *slowly* until all vegetables are tender. Serve with garlic bread.

Serves two.

NOTE: For those who enjoy rice or pasta, prepare your preferred rice or macaroni according to directions on the package. Serve a portion topped with the vegetable medley. Sprinkle with your grated cheese of choice.

A Nostalgic Remembrance

weddings and wakes were important social events to the old timers. Weddings took place at the church the bride attended. Relatives and friends would attend the wedding dressed in their finest. I attended a wedding recently and a couple of people were dressed in their best-ripped jeans. The reception, which followed the wedding Mass, was usually held at the bride's parents house and most of the food would have been cooked by her mother, grandmother and aunts. If, by chance, the house was too small for all of the guests, the church hall (usually in the basement of the church) might be an alternative. That is providing they had ovens to keep the food warm. The bride's father would supply the wine. Most of the old timer's made wine back then and prided themselves on the positive comments made after just one glass. There would also be a couple of cases of beer and maybe bottles of rum, Canadian whiskey and Coke and ginger ale to be used as mixers. For the after dinner crowd, homemade anisette of various colors were on a des-

sert table for the choosing. Chances were that living arrangements were simple for the newly married couple. They would live on one of the floors of the three-decker that either the groom or bride's parents owned. Whoever was living there would have been given a few months notice and the vacated apartment would have been readied for the arrival of the newlyweds.

Honeymoons, that was for the Americani. The Monday after the wedding saw the husband heading back to work as usual and the bride taking care of the new living accommodations. Chances are, that if the bride worked before she was married, she wouldn't continue in the work force after the wedding. People might talk, "Maybe he doesn't make enough money to support her and she has to work." Her place was now in the home, home. Yes, there were fuand that's where she stayed. neral parlors, but the Italian A few months later, the word would be out within the familv that the bride was in a family way. No one used the word pregnant back then and the witches in the family would start counting how many months pregnant the bride might be, hoping for material for gossip sessions. Today,

Chances are the couple lived together prior to their marriage. Chances are, also, that the marriage might not be in the Church, as intermarriage is quite common among the young folks of today. Chances are that the wife has a career of her own, and after her nuptials, she continues with it. Chances are that an exotic honeymoon had been planned when the wedding plans were put together and after the wedding reception, which is usually held at a K of C hall, hotel banquet room or a facility that caters to all types of functions like Spinelli's or Montvale Plaza, off goes the couple for a week or two to an exotic destination.

One new theme for a wedding is a farm location somewhere in the mountains. Many old farms have been converted into function facilities to accommodate young people who insist on this concept for their reception. More likely than not, the newlyweds will live away from both sets of parents. Many careers will even cause the young folks to move out of state, something unheard of generations ago. With the old timers gone, the neighborhoods of East Boston and the North End have more non-Italians than the ethnic group that once identified them. If I had a nickel for every time someone asked me where I came from and I told them East Boston, I would always get a response like, "Oh, you mean Easta Bosta." Yeah, I would have a lot of nickels today. The Italians have moved to the suburbs of Boston, mostly north, some west and a few south. The new comers have taken over the streets we were born and brought up on. It's their turn now. We've climbed the next rung of the social ladder and a few above that one. too.

I've mentioned the thematic format for the old time weddings. The wakes were different back then. When someone died, a three-day wake was held in the person's tradition was three days in the home. Today, all arrangements take place at a funeral home. The deceased is embalmed and put on display by the funeral director and the wake is one day, usually from 4:00 pm, until 8:00 pm. The funeral follows on the following day with some mourners it's different. appearing just for the wake

and others joining the funeral procession the next day. Following the visit to the cemetery, an invitation to dine at a restaurant function room or function halls like Spinelli's or Montvale Plaza is often protocol.

A very close friend was buried last week and I attended both the wake and the funeral. Bill Hurley was a Renaissance man. He started out working on the docks of Boston to make money, and by the end of his life, had earned a doctorate, rose to the rank of general in the Army National Guard, been given the title of professor and CEO of a business he and his wife started from scratch.

Bill's health began to fail several years ago and he developed a form of Lou Gehrig's disease. But, he was active right up to the end. Bill was waked and buried with military honors last weekend. We belonged to the same military organization, the First Corps of Cadets, and along with members from all branches of the military, we stood as sentinels as mourners paid tribute to a great man. His Wife, Sandra, his four children and all of the grandchildren were on hand to participate in a funeral Mass in Bill's honor. When we arrived at Bill's church for the funeral Mass, I looked at one of the priests and froze. It was the same man who visited me at Mass General last year and gave me Communion following a bout with brain surgery. When I spoke to the priest, Fr. Joseph, he placed his hand on my head and I could feel an energy force run through my body. Don't ask me to explain it, but it happened at the hospital when he touched my head after the operation and it happened again last week.

Following the military ceremony at the cemetery, we headed for the Winthrop Yacht Club and joined the Hurley family and their guests for an Italian dinner. In conversation, no one mourned the passing of a friend or colleague. The con-


In a game that was closer than most expected, with the possible exception of Raider Nation faithful, the Patriots defeated the Oakland Raiders 16-9. The early season offensive struggles continued in their Gillette Stadium home opener.

Outside of a second quarter Tom Brady touchdown pass to Rob Gronkowski, with the end zone within striking distance, the Patriots offense was settling for field goals. Fortunately, the Raiders never found the end zone, coming close in the waning moments, before coming undone when Vince Wilfork snagged a deflected ball with 51 seconds to play in the game. "It was a team play," said Wilfork, "I just happened to catch it." With a secondary that features Darrelle Revis, Devin McCourty and ballhawker Logan Ryan, Wilfork is now tied for first in team interceptions this season.

The New England defense continued to play well allowing 174 yards through the air and only 67 on the ground. It wasn't a dominating performance, but they were clearly the team's best unit on the field on Sunday.

Quarterback Tom Brady's numbers were decent, as he completed 24 of 37 passes for 234 yards. But with only one touchdown and with his continued reliance on Julian Edelman (isn't anyone else open?) who caught 10 passes for 84 yards, the offense looked one-dimensional. In fact outside of 10 points in the last 4:14 of the second quarter, the Oakland defense stymied the New England attack. The Raiders came into the game with the NFL's worst rushing defense, and yet the Patriots finished with just 79 yards on the ground, completely abandoning the run in the second half.

The offensive play-calling of Coordinator Josh McDaniels was very questionable throughout the game, but no more glaring than when the Patriots had a first and goal



at the Oakland two yard line and failed to get into the end zone on three tries. Two running plays by Ridley and Vereen setup a third down errant snap that Brady fumbled, but was fortunate to recover before throwing in-

complete into the end zone. "This game comes down to three things: ball security, third downs and the red area, and we have to get better at the red area." said Edelman. On that particular play, the Patriots failed at each of those categories. Send out the field goal unit.

Against another opponent, the Patriots would not have been so lucky. It was the ineptitude of the Raiders offense that allowed the Patriots to win.

However, despite all their issues, the Patriots sit atop the AFC East with a 2-1 record. Following the game, Edelman put it best, "Sometimes you got to grind them out, an ugly win is better than a pretty loss."

ule in 51 years. Padre Pio had the ability to read the hearts of the penitents who flocked to him for confession which he heard for ten or twelve hours per day. The confessional was his means of bringing both sinners and devout souls closer to God; he would know just the right word of counsel or encouragement that was needed. Even before his death, people spoke of the

possibility of his canonization. He died on September 23, 1968 at the age of eighty-one. It is estimated that his funeral was attended by approximately 100,000 people.

On June 16, 2002, over 500,000 people gathered in Rome to witness Pope John Paul II proclaim Padre Pio, Saint Pio of Pietrelcina. His feast day is celebrated on September 23rd.


Ring 4 Hall of Famer Todd Peters Shares Rare Photos of Paul Pender


